**AN ORDINANCE OF THE BOROUGH OF VERONA, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 244 ARTICLE III §244-20 OF THE CODIFIED ORDINANCES OF THE BOROUGH OF VERONA PROHIBITING PARKING AT ALL TIMES ON THE SOUTH SIDE OF SOUTH AVENUE BETWEEN ALLEGHENY RIVER BOULEVARD AND BRUNOT STREET AND AMENDING CHAPTER 244 ARTICLE III §244-26 OF THE CODIFIED ORDINANCES OF THE BOROUGH OF VERONA PROHIBITING PARKING FOR NO LONGER THAN TWO CONSECUTIVE HOURS ON THE NORTH SIDE OF SOUTH AVENUE BETWEEN ALLEGHENY RIVER BOULEVARD AND BRUNOT STREET AND AUTHORIZING SIGNAGE AND TOWING IN THE RESTRICTED AREA.**

**WHEREAS,** the Pennsylvania Borough Code grants Boroughs the right to regulate parking within the Borough limits; and

**WHEREAS,** Borough of Verona currently regulates parking on roadways and parking lots within the Borough; and

**WHEREAS,** the Borough of Verona desires to regulate parking on a portion of South Avenue between Allegheny River Boulevard and Brunot Street prohibiting parking at all times on the south side of South Avenue and limiting parking on the north side of South Avenue to no longer than two consecutive hours; and

**NOW, THEREFORE, BE IT ORDAINED** and it is hereby ordained and enacted by the Council of the Borough of Verona, Allegheny County, Pennsylvania, at a duly convened meeting, quorum present as follows:

**SECTION I. AMENDING CHAPTER 244 ARTICLE III §244-20 TO PROHIBIT PARKING AT ALL TIMES ON THE SOUTH SIDE OF SOUTH AVENUE BETWEEN ALLEGHENY RIVER BOULEVARD AND BRUNOT STREET**

The Borough of Verona hereby amends Chapter 244, Article III §244-20 of the Codified Ordinances of the Borough of Verona entitled “Parking time limited in specific locations certain days and hours”, to prohibit parking at all times as follows:

Street	Side	Location
South Avenue	South	Allegheny River Boulevard to Brunot Street

**SECTION II. AMENDING CHAPTER 244 ARTICLE III §244-26 TO PROHIBIT PARKING FOR NO LONGER THAN TWO CONSECUTIVE HOURS ON THE NORTH SIDE OF SOUTH AVENUE BETWEEN ALLEGHENY RIVER BOULEVARD AND BRUNOT STREET**

The Borough of Verona hereby amends Chapter 244, Article III §244-26 of the Codified Ordinances of the Borough of Verona entitled "Parking time limited in specific locations certain days and hours.", prohibiting parking for longer than two consecutive hours as follows:

Street	Side	Location
South Avenue	North	Allegheny River Boulevard to Brunot Street

**SECTION III. AUTHORIZING SIGNAGE**

The Borough of Verona Public Works/Street Department is hereby authorized to take appropriate measures to place no parking tow away zone signage and paint lines to designate the location of the restricted parking area.

**SECTION IV. AUTHORIZION TO TOW**

In addition to any other penalty authorized, the Borough hereby authorizes its police officers and code enforcement officers to tow any vehicle determined to be in violation of the terms of this subsection. The owner of the vehicle shall be responsible for any towing and storage charges incurred as a result of this enforcement.

**SECTION V. REPEALS**

All other Ordinances of the Borough of Verona which are in conflict with this Ordinance are hereby repealed to extent of such conflict.

**SECTION VI. SEVERABILITY**

It is hereby declared to be the intention of the Council of the Borough of Verona that the several provisions of this Ordinance are separable. If any Court of competent jurisdiction shall declare any words, sentences, sections, or provisions of this Ordinance to be invalid, such a ruling shall not affect any other words, sentences, sections or provisions of this Ordinance not specifically included in said ruling.

**SECTION VII. EFFECTIVE DATE**

This ordinance shall take effect immediately upon its approval.
